**(Terms & Conditions)**

1. This agreement is made between bookbomb.com and  
\_\_\_\_\_ (Hereinafter referred to as the Exhibitor).
2. The Exhibitor agrees to place for public sale that priced material which is consistent with this type of event and befitting the high standards of the antiquarian book trade.
3. The Exhibitor agrees not to use any material (includes tape), objects, or display systems that would cause damage to walls, floors, tables, chairs or in any way deface the exhibit hall (or furniture within it).
4. The Exhibitor agrees to indemnify, defend and hold harmless bookbomb.com , the Sacramento Scottish Rite Temple Inc., the show director, and their respective employees, agents and representatives from any and all claims, losses, costs, or any and all liabilities occurring from or in any way connected with this exhibition or exhibition related activities.
5. Exhibitors will be issued badges that must be worn at all times in the exhibit hall.
6. The Exhibitor agrees not to sub-let any space nor to augment the display space in any way without first securing the show director's approval.
7. The Exhibitor agrees that if s/he chooses to exhibit material which is predominantly of a sexually graphic or sexually explicit nature (this includes nudity) this material will be labeled as such, and the exhibitor will not display this material in a manner that will subject anyone to be exposed to it, except by their own choice, through the act of opening or uncovering it themselves
8. The Exhibitor agrees to have no radios or televisions that are audible or visible to the public, except for the purpose of educational, book related programming.
9. The Exhibitor agrees not to visually advertise that they are "wholesaling", "discounting", or that, in any way, they have their books on "sale".
10. The Exhibitor must maintain their exhibits within the width & length of the booth space rented, unless they first secure the approval of the book fair director.
11. Any booth helpers who maintain a separate book business from the exhibitor and/or any booth helpers who are not regular employees of or family members of the exhibitor shall not be allowed to purchase from or be in any other booth prior to the opening of the show.
12. Cancellations by August 15<sup>th</sup> will be charged a \$50.00 cancellation fee. Cancellation refunds after 8/15 are at the discretion of the book fair director.
